The County Jail Report for the month of April was reviewed by the Board and approved.

The Board approved the annual report submitted by the City of Osceola for their TIF program.

A motion was made by Boruch to cast Polk County's vote for Tim Hofbauer as the East Central Region representative on the Nebraska Regional Interoperability Network Board of Directors. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye.

The renewal of the NACO Blue Cross – Blue Shield health insurance plan for county employees was reviewed. This year the plan will see a 1.6% decrease in the premiums for the plan year which begins July 1<sup>st</sup> with no major changes to the plan itself. A motion was made by Boss to renew the \$2600 deductible PPO health insurance plan with the NACO Blue Cross Blue Shield group and to reimburse to the employee that portion of the deductible between \$500 and \$2600 that they themselves meet. In essence, the plan will be a \$500 deductible plan for the employee themselves and a \$2600 deductible plan for the spouse/children or family coverage paid for by those employees who wish to insure their family members through the county's group plan. The motion was seconded by Boruch and the roll call vote was Westring, aye; Boss, aye; Boruch, aye. Participation in the NACO health insurance program also provides life insurance and long term disability insurance to county employees who enroll in the plan.

Keithan Karn, with The Garland Company, Inc., conducted the mandatory pre-bid conference in the county boardroom, beginning at 10:00 a.m., for the courthouse re-roof project. Representatives from seven companies were present for the meeting. Following the review of the project specifications, the roof was inspected by the representatives of the contractors. Sealed bids for the project will be opened at 10:00 a.m. on May 21<sup>st</sup> during the County Board meeting.

At 10:20 a.m., a motion was made by Boruch to go into executive session to discuss possible litigation issues. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. Also present were Sheriff Ladwig and the County Clerk. At 10:35 a.m., a motion was made by Boruch to come out of executive session. The motion was seconded by Boss and the roll call vote was Boruch, aye; Boss, aye; Westring, aye. Chairman Westring stated for the record that no formal action was taken and only potential litigation issues were discussed.

Sheriff Ladwig discussed the need to purchase additional patrol vehicles. Using the state bid process, there only Chevrolet Tahoes currently available for purchase. Other patrol vehicles are either unavailable or would need to be ordered with a delivery date well into the future. Official action on purchase patrol vehicles will be placed on the agenda of the May 21<sup>st</sup> regular meeting.

Highway Supt. Theis updated the Board on the work being done in the Road Dept. The scrap tire collection held at the end of last week went well but due to the amount of tires collected the first two days and the forecasted rain for Friday night, the collection was cancelled for Saturday. Champlin Tire Recycling, Inc. began hauling the tires away on Monday. Stop signs and stop ahead signs which are part of the State's High Risk Rural Road program have been ordered by the NDOT. Several roads experienced run-off problems following the weekend's heavy rains. The project information for resurfacing Osceola North and Shelby North blacktops was successfully submitted to Congressman Flood's office to be presented to the House of Representative's appropriations committee.

There being no further business, the Board adjourned at 12:00 p.m. to meet again on May 21<sup>st</sup> and 28<sup>th</sup>, 2024. An agenda of the meetings will be available at the office of the County Clerk.
